1. Review of Actions Implemented:

The committee reviewed the steps taken after the first meeting. Posters and helpline numbers have been displayed across campus, an anonymous complaint box has been set up, and an orientation session on gender sensitivity was successfully conducted for new students.

2. Number of Sexual Harassment Complaints Filed & Actions Taken:

The committee received and reviewed that no sexual harassment complaints were filed since the last review. While this was noted as a positive outcome reflecting a safe and respectful environment, members emphasized that it should not lead to complacency. Continued vigilance, active awareness, and periodic checks were stressed to maintain a healthy atmosphere and ensure that all members of the institution feel secure in reporting any issues, should they arise.

3. Evaluation of Awareness Activities:

No Awareness Activities were conducted.

4. Planning Next Phase of Preventive Measures:

Several new initiatives were planned for the next phase to strengthen preventive efforts. Refresher workshops will be conducted for both teaching and non-teaching staff to reinforce their understanding of gender sensitivity and reporting procedures. Interactive sessions and role-plays will be organized for students, helping them practice handling real-life scenarios related to harassment or discrimination. The committee also decided to continue regular monitoring of the anonymous suggestion box to ensure timely attention to any inputs.

Additionally, the institutional website will be updated to include a dedicated FAQ section on harassment policies, making information easily accessible to everyone.
